#### International Vulture Awareness Day

The first Saturday of September is always the international vulture awareness day! An intriguing synthesis paper by Dr. Steffen Oppel *et al.*, published recently in Biological Conservation examines the threats to Egyptian Vultures and other raptors in 13 countries along the flyway. The paper can be accessed for free until October <u>here</u>.

#### Champions of the Flyway: Year of the Dove

The "Year of the Dove" campaign is in full swing, as Turtle Doves return to their wintering grounds. Follow the first race happening in North Israel on 30th Sept 2021. The population of the European Turtle Dove has <u>decreased by 30% in the last 15 years</u>, yet they are both legally and illegally massacred in several countries along their flyway. #### Wildlife Crime Academy launches!

The Spanish Government, the Junta de Andalucía, together with an international NGO, the <u>Vulture Conservation Foundation</u> (VCF), held the first-ever Wildlife Crime Academy in Spain within the scope of the BalkanDetox LIFE project. A total of 34 professionals working in conservation, law enforcement and forensic science travelled from all over Europe to learn how to investigate wildlife crime. <u>Read more</u>

#### France bans the use of glue traps

Kudos to BirdLife's partner in France, Ligue pour la Protection des Oiseaux (LPO) which managed to put an end to songbird trapping with glue traps in France. Following legal action by LPO, France's highest court has now ruled that this practice is illegal, saying that an exemption that had permitted it was in breach of European legislation. The European Court of Justice (ECJ) had earlier judged this practice as incompatible with EU law. Read more <u>here (in English) or here</u> (in French).

#### Horrible mass poisoning events in Europe

Nearly 100 vultures were found dead or dying in a <u>mass poisoning</u> <u>in Spain in June</u>. Later the investigation revealed that it was caused by carbofuran – a powerful pesticide that has been banned in the EU since 2008.





## The most serious poisoning case ever recorded in Hungary discovered in August

The first searches revealed more than a hundred poisoned baits infected with a type of strong neurotoxin - and more than one hundred poisoned animal carcasses were found! 96% of the carcasses were protected birds, the majority, being Marsh Harriers (*Circus aeruginosus*). Subsequent fieldwork further increased the number of findings since this linked article. Investigation is ongoing.

#### Raptors also fall victim to illegal shooting in France

This time a Griffon vulture was shot. LPO calls on the law enforcement authorities and the leaders of hunters' organisations to act, as the perpetrators of these scandalous acts are rarely get caught and condemned. Read more <u>here</u>.





#### Malta finch trapping

Finch trapping in Malta is coming to an end! On 9 June the European Commission issued a final warning to Malta as it announced that a Reasoned Opinion has been sent to the Maltese Government in relation to the infringement procedure initiated against Malta in December on finch trapping under the false pretence of a scientific and research study.
